

Mora Conservation Area

Recreational Opportunities

Bird Watching – Fishing – Hunting – Hiking –
Outdoor Photography – Picnicking – Frogging

Conservation areas are closed from 10 p.m. to 4 a.m. except for authorized camping, fishing, and hunting activities.

Rules and Regulations

- No littering.
- No fireworks.
- No open fires.
- No free-running pets. Dogs must be leashed or confined when not being used for hunting or training.
- Motor vehicles are restricted to roadways and parking areas.
- Destroying, cutting or removing vegetation is prohibited. Nuts, berries, fruits, edible wild greens and mushrooms may be taken only for personal consumption.
- No digging or soil disturbance is allowed.
- Horseback riding is not permitted.
- Bicycles are allowed only on roads open to vehicles and service roads.
- No camping permitted.
- No target shooting allowed.
- Trail and game cameras are prohibited.

Fishing

Fishing and frogging are permitted under statewide regulations with the following exceptions:

- In ponds, fish may be taken only by pole and line and not more than three poles and lines may be used by any one person.
- In ponds, daily and possession limits are six black bass, four catfish in the aggregate (channel, blue and flathead catfish) and 30 crappie. All other fish are not to exceed 20 in the aggregate.
- In ponds, all black bass between 12 and 15 inches in total length must be returned to the water unharmed immediately after being caught.
- Some ponds may be posted closed to fishing.
- Seining or trapping live bait, including tadpoles, is prohibited on all lakes and ponds, excepted as otherwise provided in this chapter.

Hunting and Trapping

Area is open to hunting. The following special regulations apply:

- Prairie chickens are a protected species and may not be hunted.
- Deer hunting is permitted under statewide season and limits except: archery and firearms antlerless permits may not be used. The area is closed to firearms deer hunting during the urban and antlerless portions of the firearms deer season.
- Only bucks with at least 4-points on one side of their rack may be taken during the firearms and archery seasons except for the firearms youth portions when any buck is legal.
- Only portable tree stands are allowed and only from Sept. 1 through Jan. 31. Unattended stands must be plainly labeled on a durable material with the full name and address, or Conservation Number, of the owner and must be removed from the area before Feb. 1. Use of nails, screw-in steps, and any material or method that would damage the tree is prohibited.
- Trapping of furbearers is allowed only with a special use permit.



