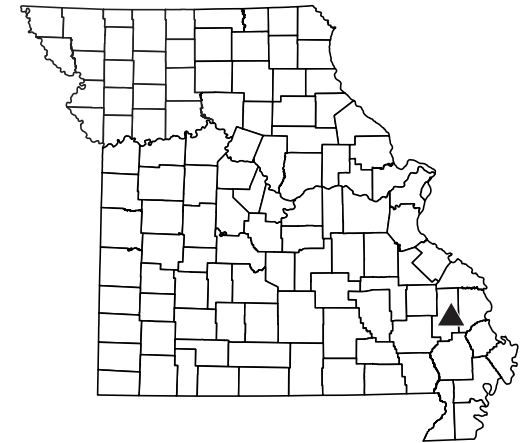

## RECREATIONAL OPPORTUNITIES

Bird Watching — Bicycling — Camping  
Fishing — Hiking — Horseback Riding  
Hunting — Shooting Range

*Conservation Areas are closed from 10 p.m. to 4 a.m. except for authorized camping, fishing and hunting activities.*

- No littering.
- No fireworks.
- No open fires except in designated areas. Campfires must be attended at all times.
- Pets must be leashed when not used for training or hunting.
- Nuts, berries, fruits, mushrooms and wild greens may be taken for personal use. Taking of greens from areas designated as Natural Areas is prohibited. Cutting or removing other vegetation is prohibited.
- Motor vehicles are allowed on public roadways and in parking areas.
- Horseback riding is permitted only on roads open to public vehicles and on designated horse trails.
- Campers are limited to 14 consecutive days in a 30-day period. Groups of 10 or more campers need a special use permit. Contact Resource Forester in Marble Hill.
- Primitive camping on a walk-in basis is allowed, but campsites must be at least 100 yards from all public access roads, open fields and parking lots.

- For safety reasons target shooting is permitted only at the shooting range.

- ATV's are prohibited.

## Fishing and Boating

*Fishing and frogging are allowed under statewide regulations with the following exceptions on impoundments:*

- Fish may be taken only by pole and line and not more than 3 poles may be used by any person.
- Daily limit is 6 black bass, 4 catfish (channel, blue and flathead combined) and 30 crappie. Total number of all other fish may not exceed 20.
- All black bass less than 15 inches must be returned to the water unharmed immediately after being caught.
- Seining or trapping live bait, including tadpoles, is prohibited.
- Salvage seining of non-game fish for personal use is permitted only with written authorization.
- Boats may not be left unattended overnight.
- Only electric motors are permitted.



## Hunting and Trapping

*Hunting is allowed under statewide regulations with the following exceptions:*

- Deer and turkey regulations are subject to annual changes. Please refer to Spring Turkey and Fall Deer and Turkey summaries for current regulations.
- Only portable tree stands are allowed and only from September 1 through January 31. Unattended stands must be plainly labeled on a durable material with the full name and address, or Conservation Number, of the owner and be removed from the area before February 1. Use of nails, screw-in steps, and any material or method that would damage the tree is prohibited.
- Furbearer trapping is permitted by special use permit.
