## MANAGEMENT CONSIDERATIONS

### IV. Terrestrial Resource Management Considerations

The lake is surrounded by pine and mixed hardwood forests. A residential area is present along the south boundary line.

#### **Challenges and Opportunities:**

- 1) Maintain healthy forests to protect watershed.
- 2) Maintain muskrat and beaver populations at acceptable levels.

**Management Objective 1:** Maintain healthy forests.

**Strategy 1:** Monitor, at least annually, for priority invasive exotic species and control as needed. (Forestry)

**Strategy 2:** Inspect, at least annually, for any forest insect or disease issues and develop strategies to control any issues that might arise. (Forestry)

**Management Objective 2:** Maintain muskrat and beaver populations at acceptable levels.

**Strategy 1:** Continue to utilize trappers to keep aquatic mammal populations at levels that minimize damage to the shoreline, dam and lakeside vegetation. (Forestry)

## APPENDICES

### Area Background:

This 57-acre area is primarily forested. Amenities include a concrete boat ramp, picnic areas, pavilion, fishing dock and a 22-acre fishing lake.

To access this area, go 4 miles west of Cabool on Highway 60, 0.75 miles north on Route MM and 0.5 miles east on Greenwood Road.

### Public Input Summary:

The draft Austin Community Lake Area Management Plan was available for a public comment period January 1–31, 2016. The Missouri Department of Conservation received comments from three respondents (Appendix A). The Austin Community Lake Area Planning Team carefully reviewed and considered these ideas as they finalized this document. A brief summary of public input themes, including how they were incorporated or why they were not, can be found below. Rather than respond to each individual comment, comments are grouped into general themes and are addressed collectively.

Department responses to themes and issues identified through the Austin Community Lake Area public comment period

### **Suggests adding a hiking trail around the lake (possibly ADA accessible) with places for bank fishing.**

The idea of looking into the feasibility of a hiking trail is a component of this area plan. We will continue with that intent and see what develops with our assessment. We currently provide ADA accessible parking, privies, fishing dock, and pavilion with picnic tables.

### **Suggests adding trash barrels to combat littering.**

Littering is a constant issue with all our areas. We have learned over the years that trash barrels do not automatically relieve an area of littering. In fact, we have as much, if not

more, trash where we have trash barrels. With limited staff time, we have found it more efficient to encourage users to pack out what they pack in.

**Concerned with loitering on area. Suggests greater surveillance.**

We are very interested in taking care of any illegal activity that is taking place at Austin Lake CA. If you see or hear of inappropriate or illegal activity at any of our areas, we encourage you to contact the local conservation agent. **Suggests a better entrance sign. Lake is difficult to find.**

Thank you for the comment. We were not aware this was an issue. We will explore replacing the entrance sign with something larger.

**Concern about fence along border needing repair.**

We maintain boundary lines on a five-year rotation. The area manager and forestry regional supervisor are planning on looking at the boundary in question and will resolve any existing issues.

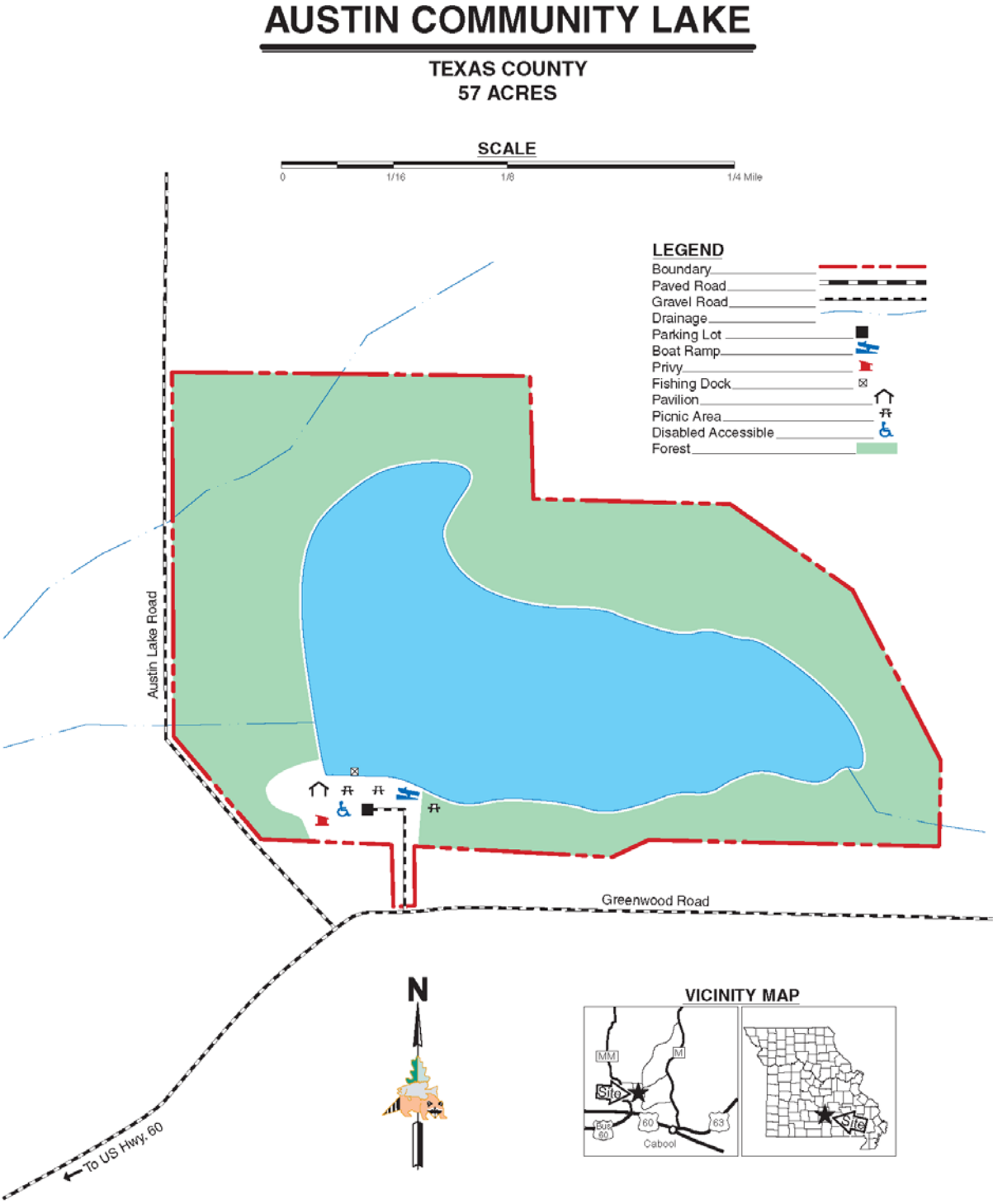
Figure 1: Area Map

**Appendix A: Austin Community Lake Area Management Plan Public Comments**

Received during public comment period (January 1-31, 2016):

(Hardcopy comment received on 1/4/2016)The lake needs trash barrels. Littering and "loitering" is bad. More surveylance is needed.

(Hardcopy comment received on 1/11/2016): Austin Lake is a very well kept recreational area - many people from all of this area use it for picnics, fishing, family reunions and just a place to get away from the pressures of everyday life and relax -- MDC does a very good job of keeping it cleaned up and mowed! I wish there was a better sign showing the entrance. We live just north of the lake on Austin Lake Road. Our property joins the MDC property on the northside. During the spring & summer months several people stop and ask "Where is the lake"? Another thing - the fence between us is in bad shape, I have called several times over the years - 30 - asking for help. When I had cattle and they got out MDC was quick to tell me to get them off the property. I kept it mended as best I could but at times trees or limbs from both sides would fall across it.

Hiking/walking trail around perimeter of lake would be fantastic. With a little imagination and planning, the trail could be one full mile around the lake. Possibly even a footbridge or two, especially on the east side of lake. A concrete sidewalk could also be made around the lake to allow for those with physical disabilities to also enjoy the full area. Concrete pads can be placed for bank fishing.
