Bird Watching – Fishing – Hiking – Camping – Hunting – Outdoor Photography – Wildlife Viewing

Rules and Regulations

Open for public use from 4:00 a.m. to 10:00 p.m.; hunting fishing, trapping, camping, dog training, launching and landing boats allowed 24 hours a day on areas where these activities are permitted.

- Digging of roots is prohibited on all Conservation areas.
- The taking of mushrooms, nuts, berries, fruits and edible wild greens for personal consumption is permitted.
- Use of fireworks are prohibited.
- Pets and hunting dogs are permitted but must be on a leash or confined at all time. Hunting dogs may be used off the leash and unconfined for hunting and training purposes. Hunting permit required to train dogs in pursuit of wildlife.
- No bicycling opportunity except on public roadways.
- Target shooting not allowed.

Fishing and Boating

Fishing and frogging are allowed under statewide regulations with the following exceptions.

- Seining or trapping live bait is permitted in streams.
- Boats may be used only for fishing and wildlife activities and may not be left unattended overnight.

Hunting and Trapping

Hunting is allowed under statewide regulations with the following exceptions.

- Decoys and portable blinds are permitted but must be removed from the area daily. Blinds may be constructed on-site only from willows (Salicaceae) and nonwoody vegetation.
- Only portable stands are allowed from September 1 through January 31. Unattended stands must be plainly labeled on a durable material with the full name and address or Conservation number of the owner and be removed from the area by February 1st. Use of nails, screw-in steps, and any material or method that would damage the tree is prohibited.
- Trapping allowed only with special use permit. Contact area manager.
- Deer and turkey regulations are subject to annual changes. Please refer to Spring Turkey or Fall Deer and Turkey summaries for current regulations.

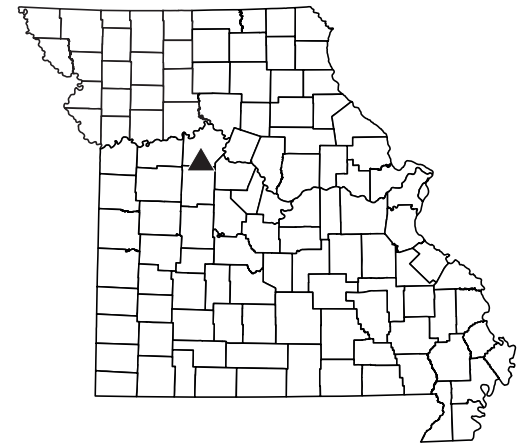
